### LIMITED WARRANTY

#### UPONOR LTD. LIMITED WARRANTY

**Valid for AQUAPEX™ Tubing and Quick and Easy Potable Water** Plumbing Components To Property Owners and Succeeding Owners During Warranty Period. This Warranty Revision is Effective January 1, 1998.

**Limited Warranty:** *Uponor* warrants to the property owners and succeeding owners that AQUAPEX™ tubing and the Quick and Easy fitting system shall be free from defects in material and workmanship, under normal conditions of use, when used for potable water distribution.

For AQUAPEX™ tubing, manifolds and Quick and Easy fittings installed by licensed plumbing contractors employing certified plumbing personnel and recognized by *Uponor* as an "Uponor Trained Installer" this limited warranty shall expire in: twenty-five (25) years for AQUAPEX™ tubing, twenty-five (25) years for AQUAPEX™ Quick and Easy fittings and twenty-five years for the integrity of the assembly of AQUAPEX™ tubing and AQUAPEX™ Quick and Easy fittings to maintain a leak-proof seal. AQUAPEX™ basin and tank risers, and all valves and stops sold by *Uponor* are warranted for one (1) year. All warranty periods are measured from date of installation.

*Uponor* must receive written notification of a believed failure within the applicable warranty period, and within thirty (30) days of the believed breach. *Uponor* shall have not less than ninety (90) business days in which to determine whether it acknowledges responsibility for any believed defects in material or workmanship.

Emergency repairs may be carried out without notification. Allowances, for all emergency work done, are at the discretion of *Uponor*. Documentation on failures must be provided including components and acceptable length of tubing (for testing) that failed.

It is agreed that the exclusive remedies under this limited warranty are for manufacturer's defects. *Uponor* will repair or replace any tubing or fittings, which are proven to be defective and pay for consequential damages. Reimbursement for other related cost is at the discretion of *Uponor*.

This limited warranty applies only if the articles sold hereunder are: selected, designed, and installed by a licensed plumbing contractor

employing certified plumbing personnel with recognition as an "Uponor Trained Installer" according to (a) the then current (time of installation) installation instructions provided by *Uponor*, (b) are not exposed to temperatures, pressures or temperatures and pressures that exceed the limitations printed on the tubing, or limitations stated in the manufacturers specification (c) remain in their originally installed location, (d) are connected to potable water supplies, (e) show no evidence of mishandling, or accidental damage as a result of water freezing in the pipes, or use of chemicals other than those acceptable for potable use or listed in *Uponor* manuals, (f) are installed in accordance with local building and plumbing codes and bylaws. The above is the full extent of the warranty provided by *Uponor*.

By the mutual agreement of the parties, it is agreed that this limited warranty and any claims arising from breach of contract, breach of warranty, or any other claim arising hereunder, shall be governed and construed under the laws of the Province of Saskatchewan. The Province of Saskatchewan will be the proper jurisdiction for the determination of any claims. An owner or succeeding owner must cooperate fully on a reasonable basis. It is expressly understood that authorized *Uponor* Sales Representatives, Distributors and Factory Trained Plumbing Professionals have no authority to bind *Uponor* to any agreement or warranty of any kind without the written consent of *Uponor*.
